BARRE/MONTPELIER/WATERBURY RECYCLING GUIDELINES

Paper and Other Fibers (3 separate bins)

1) White and Colored Office Paper:

- All printer & copier paper including letterhead
- Copy paper wrappers (marked as recyclable)
- Computer printouts
- Cardstock including business cards
- Shredded paper (not crosscut or confetti)
- Carbonless (NCR) multi-part paper
- Any non-glossy colored paper including cover stock
- Envelopes (remove cellophane from windows)

2) Newspaper, Magazines and Glossy Junk Mail:

- Newspapers including any inserts
- Magazines
- Glossy junk mail

3) Corrugated Cardboard & Boxboard:

- Please flatten and remove as much tape as possible
- Thin cardboard, grey or brown interior
- Brown paper bags and brown paper packing material
- No pizza boxes or waxed cardboard

Other Recyclable Materials (2 separate bins)

1) Bottles & Cans:

(clean, no plastic lids under 2")

- Glass bottles & jars, neck rings & labels are okay
 - No bottle caps, light bulbs, dishes,
 Pyrex, drinking glasses or window panes
- Metal cans, lids are okay inside can
 - No household scrap metal
- Aluminum cans, foil & pie plates
- #1 through #7 plastics (check container)
 - Bottles and jugs for soda
 - Condiments
 - Beauty products
 - Detergents
 - Cleaners
 - Dairy tubs (like yogurt & ice cream)
 - Hard plastic frozen food trays
 - No plastic bags, plastic wrap, Styrofoam products, plastic film, electronics housing, or household or office products

2) Other Items:

- Telephone Books
- Hard Cover Books

Surplus Property Reuse & Recycling

- All material, equipment, and supplies found to be surplus by state agencies and departments
- Items are made available for resale, reuse, e-waste recycling, metal recycling, or other disposal as appropriate
- State surplus cell phones

Collection Boxes & Pickup Service

1) Recyclable Batteries:

(contact closest BGS District for collection boxes)

- Nickel Cadmium (NiCd)
- Lithium Ion (Li Ion)
- Nickel Metal Hydride (NiMH)
- Small lead (Pb)
- Batteries less than two pounds
 - Cordless power tools
 - Cell phones and cordless phones
 - Laptops
 - Digital cameras and camcorders
 - Two-way radios

2) Fluorescent Light Bulbs
