### CONTRACT TERMS AND ADDITIONAL INFORMATION

SCOPE OF CONTRACT: TO PROVIDE AUTOMOTIVE SAFETY REPLACEMENT AND REPAIR TO VARIOUS STATE AGENCIES AND POLITICAL SUBDIVISIONS WITHIN VERMONT

CONTRACT TERM: THIS CONTRACT IS WRITTEN FOR A PERIOD OF TWENTY-FOUR (24) MONTHS WITH THE OPTION TO RENEW FOR TWO (2) ADDITIONAL TWELVE MONTH PERIODS.

CONTRACTOR'S EMPLOYEES SHALL BE CERTIFIED BY THE NATIONAL AUTO GLASS ASSOCIATION TO INSTALL AND REPAIR WINDSHIELDS.

ALL VEHICLES REQUIRING AUTO GLASS REPLACEMENT ARE TO BE RETURNED TO THE MANUFACTURER'S ORIGINAL INTENDED SAFETY LEVELS. EXCEPTION: FOR AUTO GLASS REPLACEMENT IN TEMPERATURES BELOW 40 DEGREES FAHRENHEIT, TECHNICIANS MUST UTILIZE ORIGINAL EQUIPMENT MANUFACTURER APPROVED TWO-PART CHEMICAL CURED URETHANE THAT MEET THE FOLLOWING CRITERIA:

DOCUMENTED PROOF THAT THE URETHANE USED WILL REACH 250 PSI OF LAP SHEAR STRENGTH IN ONE HOUR DOWN TO ZERO DEGREES FAHRENHEIT.

TRUCK SLIDING BACK GLASS IS WARRANTY AGAINST DEFECTS IN MATERIAL AND WORKMANSHIP FOR TWO YEARS FROM THE DATE OF INSTALLATION AS SHOWN ON THE INVOICE.

EXCLUSIONS: THIS WARRANTY DOES NOT COVER LEAKS, STRESS CRACKS, OR RELATED DAMAGE IN CONNECTION WITH INSTALLATION TO VEHICLES HAVING DAMAGE OR RUST ON THE PINCHWELD. SAFELITE WILL USE COMMERCIALY RESPONSIBLE EFFORTS TO ADVISE YOU OF THE EXISTENCE OF SUCH DAMAGE OR RUST PRIOR TO REMOVAL OF EXISTING GLASS; HOWEVER, IT IS OFTEN NOT POSSIBLE TO DO THIS. IN THESE CASES, SAFELITE IS NOT RESPONSIBLE FOR ANY ASSOCIATED DAMAGE. IN ADDITION, DAMAGE NOT INVOLVING DEFECTIVE WORKMANSHIP OR MATERIALS IS EXPRESSLY EXCLUDED FROM COVERAGE UNDER THIS WARRANTY. IN NO EVENT SHALL THE MANUFACTURER OR CONTRACTOR BE RELIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. IF STATES DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS, WHICH VARY FROM STATE TO STATE.

WARRANTY REPLACEMENT OR REPAIRS: COSTOMER MAY CONTACT ANY CONTRACTOR;S STORES OR PHONE TOLL FREE 1-800-835-2257 AND CONTRACTOR WILL REPLACE OR REPAIR THE WARRANTED PRODUCT OR CORRECT THE DEFECTIVE WORKMANSHIP WITHOUT CHARGE AT A MUTUALLY AGREED UPON TIME. IF CONTRACTOR IS UNABLE TO DO SO, CONTRACTOR WILL REFUND THE CUSTOMER;S ORIGINAL PURCHASE PRICE OF WARRANTED PRODUCT. IN ORDER TO EXERCISE YOUR RIGHTS UNDER THIS WARRANTY, CONTRACTOR WILL REQUIRE EVIDENCE OF INSTALLATION BY SAFELITE, SUCH AS A COPY OF THE INVOICE ON THE FRONT OF THE WARRANTY.

TERMS OF SALE: NET 30 DAYS

QUANTITY: THE ANNUAL VALUE AND QUANTITIES ARE ESTIMATED ONLY BASED ON PRIOR USAGE; ACTUAL PURCHASES MAY BE HIGHER OR LOWER DEPENDING ON THE STATE'S NEEDS. THE CONTRACT MAXIMUM IS NOT REFLECTIVE OF ACTUAL USAGE.

DELIVERY: RESPONSIBILITY FOR PRODUCT DELIVERY REMAINS WITH THE CONTRACTOR UNTIL THE PRODUCT IS PROPERLY DELIVERED AND SIGNED FOR IN ACCORDANCE WITH THE OFFICE OF PURCHASING & CONTRACTING TERMS AND CONDITIONS. SHIPMENTS SHALL BE SECURELY AND PROPERLY PACKED, ACCORDING TO ACCEPTED COMMERCIAL PRACTICES, WITHOUT EXTRA CHARGE FOR PACKING CASES OR OTHER CONTAINERS. SUCH CONTAINERS WILL REMAIN THE PROPERTY OF THE STATE UNLESS OTHERWISE STATED. DELIVERED GOODS THAT DO NOT CONFORM TO THE SPECIFICATIONS OR ARE NOT IN GOOD CONDITION UPON RECEIPT SHALL BE REPLACED PROMPTLY BY THE CONTRACTOR.

PRICING: ALL EQUIPMENT PRICING IS TO INCLUDE F.O.B. DELIVERY TO THE ORDERING FACILITY. NO REQUEST FOR EXTRA DELIVERY COST WILL BE HONORED. ALL EQUIPMENT SHALL BE DELIVERED ASSEMBLED, SERVICED, OILED, AND READY FOR IMMEDIATE USE, UNLESS OTHERWISE REQUESTED BY THE PURCHASING AGENCY.

QUALITY: ALL PRODUCTS PROVIDED UNDER THESE AGREEMENTS WILL BE NEW AND UNUSED, UNLESS OTHERWISE STATED. FACTORY SECONDS OR REMANUFACTURED PRODUCTS WILL NOT BE ACCEPTED UNLESS SPECIFICALLY REQUESTED BY THE PURCHASING AGENCY. ALL PRODUCTS PROVIDED BY THE CONTRACTOR MUST MEET ALL FEDERAL, STATE, AND LOCAL STANDARDS FOR QUALITY AND SAFETY REQUIREMENTS. PRODUCTS NOT MEETING THESE STANDARDS WILL BE DEEMED UNACCEPTABLE AND RETURNED TO THE CONTRACTOR FOR CREDIT AT NO CHARGE TO THE STATE.

METHOD OF ORDERING: PURCHASE ORDERS MUST BE USED TO ORDER ITEMS AVAILABLE UNDER THIS CONTRACT. IF VERBAL ORDERS ARE GIVEN A CONFIRMING PURCHASE ORDER MUST BE ISSUED.

INVOICING: ALL INVOICES ARE TO BE RENDERED BY THE CONTRACTOR ON THE VENDOR'S STANDARD BILLHEAD AND FORWARDED DIRECTLY TO THE INSTITUTION OR AGENCY ORDERING MATERIALS OR SERVICES AND SHALL SPECIFY THE ADDRESS TO WHICH PAYMENTS WILL BE SENT.

CANCELLATION: THE STATE SPECIFICALLY RESERVES THE RIGHT TO CANCEL THE CONTRACT, OR ANY PORTION THEREOF, IF, IN THE OPINION OF ITS COMMISSIONER OF BUILDINGS AND GENERAL SERVICES, THE SERVICES OR MATERIALS SUPPLIED BY THE CONTRACTOR ARE NOT SATISFACTORY OR ARE NOT CONSISTENT WITH THE TERMS OF THE CONTRACT
