- 1. Parties. This is a contract for services between the State of Vermont, Department of Buildings and General Services (hereinafter called "State"), and Nachurs Alpine Solutions LLC., with a principal place of business in Marion, OH, (hereinafter called "Contractor"). Contractor's form of business organization is a Limited Liability Corporation. - 4. Contract Term. The period of contractor's performance shall begin on November 16, 2018 and end on November 15, 2020 with two 12-month renewal options.
- 5. Prior Approvals. This Contract shall not be binding unless and until all requisite prior approvals have been obtained in accordance with current State law, bulletins, and interpretations.
- 6. Amendment. No changes, modifications, or amendments in the terms and conditions of this contract shall be effective unless reduced to writing, numbered and signed by the duly authorized representative of the State and Contractor.
- 7. Termination for Convenience. This contract may be terminated by the State at any time by giving written notice at least thirty (30) days in advance. In such event, Contractor shall be paid under the terms of this contract for all services provided to and accepted by the State prior to the effective date of termination. 8. Attachments.
