STATE OF VERMONT CONTRACT AMENDMENT

It is hereby agreed by and between the State of Vermont, Department of Buildings & General Services (the "State") and Victory Supply LLC, with a principal place of business in Mount Pleasant, TN (the "Contractor") that the contract between them originally dated as of July 1, 2021, Contract # 42203, as amended to date, (the "Contract") is hereby amended as follows:

I. <u>Attachment A, Scope of Services</u>. The scope of services is amended as follows:

Section 1, 2 & 3 of Attachment A is hereby deleted in its entirety and replaced as set forth below in this Amendment.

- Pants, Inmate Uniform, Permanent press, poly/cotton blend fabric, over-lock seam construction, no pockets, hemmed bottom pull on style with elastic waistband, tri-stitch, reinforced crouch, and all strain points are bar-tacked. All seams are clearly finished and have no raw edges. Sizes: Small – 6XL. Colors: White, Postman Blue, Orange, Red, Pink, Gray Navy, Burgundy, Lime Green, Khaki, Spruce Green, Yellow and Color/white striped. Indicate Size and Color at time of order. Size and Pricing: Small – 2XL \$5.22/ea., 3XL - \$5.48/ea., 4XL - \$5.83/ea., 5XL -\$6.11/ea., 6XL - \$6.21/ea.
- Shirt, Inmate Uniform, Permanent press, poly/cotton blend fabric, skip on binding V-neck, short sleeve, one left breast pocket double needle stitched, or bar tacked, no buttons, hemmed sleeves and bottom, tri-stitch, all strain points are bar-tacked and reinforced, all seams are cleanly finished and have no raw edges. Sizes Small 6XL. Colors: White, Postman Blue, Orange, Red, Pink, Gray Navy, Burgundy, Lime Green, Khaki, Spruce Green, Yellow and Color/white striped. Indicate Size and Color at time of order. Size and Pricing: Small 2XL \$4.89/ea., 3XL \$5.11/ea., 4XL \$5.48/ea., 5XL \$5.48/ea., 6XL \$5.74/ea.
- Chore Jacket, Inmate Uniform, heavy weight, 65/35 poly/cotton twill shell, shrink resistant blanket lining, button front closure, four large front pockets and banded corduroy collar, machine washable, Colors: Orange Denim and Black/White Striped. Indicate Size and Color at time of order. Size and Pricing: Small – 2XL \$15.87/ea., 3XL - \$16.22/ea., 4XL - \$16.70/ea., 5XL & 6XL - \$16.99/ea.

<u>Taxes Due to the State</u>. Contractor certifies under the pains and penalties of perjury that, as of the date this contract amendment is signed, the Contractor is in good standing with respect to, or in full compliance with a plan to pay, any and all taxes due the State of Vermont.

<u>Child Support (Applicable to natural persons only; not applicable to corporations, partnerships or LLCs</u>). Contractor is under no obligation to pay child support or is in good standing with respect to or in full compliance with a plan to pay any and all child support payable under a support order as of the date of this amendment.

<u>Certification Regarding Suspension or Debarment</u>. Contractor certifies under the pains and penalties of perjury that, as of the date this contract amendment is signed, neither Contractor nor

Contractor's principals (officers, directors, owners, or partners) are presently debarred, suspended, proposed for debarment, declared ineligible or excluded from participation in federal programs, or programs supported in whole or in part by federal funds.

STANDARD CONTACT

1. *Parties.* This is a contract between the State of Vermont, Buildings & General Services (hereinafter called "State"), and Victory Supply LLC., with a principal place of business in Mount Pleasant, TN, (hereinafter called "Contractor"). Contractor's form of business organization is Limited Liability Company. It is Contractor's responsibility to contact the Vermont Department of Taxes to determine if, by law, Contractor is required to have a Vermont Department of Taxes Business Account Number.

2. *Subject Matter.* The subject matter of this contract is commodities generally on the subject of Inmate Pants, Shirts & Jackets. Detailed requirements to be provided by Contractor are described in Attachment A.

3. *Maximum Amount*. In consideration of the commodities to be provided by Contractor, the State agrees to pay Contractor, in accordance with the payment provisions specified in Attachment B, a sum not to exceed \$40,000.00.

4. *Contract Term.* The period of contractor's performance shall begin on July 1, 2021, and end on June 30, 2023 with the option to renew for up to two additional one year periods.

5. *Prior Approvals.* This Contract shall not be binding unless and until all requisite prior approvals have been obtained in accordance with current State law, bulletins, and interpretations.

6. *Amendment.* No changes, modifications, or amendments in the terms and conditions of this contract shall be effective unless reduced to writing, numbered and signed by the duly authorized representative of the State and Contractor.

7. *Termination/Cancellation/Rejection.* The State specifically reserves the right upon written notice to immediately terminate the contract or any portion thereof at no additional cost to the State, providing, in the opinion of its Commissioner of Buildings and General Services, the products supplied by Contractor are not satisfactory or are not consistent with the terms of this Contract. The State also specifically reserves the right upon written notice, and at no additional cost to the State, to immediately terminate the contract for convenience and/or to immediately reject or cancel any order for convenience at any time prior to shipping notification.

- Chore Jacket, Inmate Uniform, heavy weight, 65/35 poly/cotton twill shell, shrink resistant blanket lining, button front closure, four large front pockets and banded corduroy collar, machine washable, Colors: Orange Denim and Black/White Striped. Indicate Size and Color at time of order. Size and Pricing: Small – 2XL \$15.87/ea., 3XL - \$16.22/ea., 4XL - \$16.70/ea., 5XL & 6XL - \$16.99/ea.
- 4. WARRANTY: Each product purchased hereunder shall include a manufacturer's written warranty, which must be based on commercial use, and extend for a minimum term of one (1) year from the date a Product is available for use by the purchaser, or such longer period as set forth in the written warranty.
- 5. **REPORTING REQUIREMENTS:** Contractor will be required to submit quarterly product sales report to the Purchasing Agent pursuant to the schedule below detailing the purchasing of all items under this Contractor. Contractor's reporting shall state "no activity" for any month in which there is no activity during a quarterly reporting period.
 - a. The reports shall be an excel spreadsheet transmitted electronically to the Purchasing Agent.

b. Reports are due for each quarter as follows:

- c. Failure to meet these reporting requirements may result in suspension or termination of this Participating Addendum.
- d. Notwithstanding the fact that any payment obligation for sales by contractor to any political subdivision or college, pursuant to "Purchasing Entities," below, shall be solely between the political subdivision or college and the contractor, the contractor must include, in reporting to State, the figures on quantities sold by contractor to, and amounts paid to contractor by, any such political subdivisions or independent colleges.
- 6. **DELIVERY:** Responsibility for product delivery remains with Contractor until the product is properly delivered and signed for. Contractor shall securely and properly pack all shipments in accordance with accepted commercial practices. Upon delivery, all packaging and containers shall become the property of the State, unless otherwise stated. Delivered goods that do not conform to the specifications or are not in good condition upon receipt shall be replaced promptly by the Contractor.
- 7. **QUALITY:** All products will be new and unused. All products provided by the Contractor must meet all federal, state, and local standards for quality and safety requirements. Products not meeting the requirements of this section will be deemed unacceptable and returned to the Contractor for credit at no charge to the State.
- 8. **DEFAULT:** In case of default of the Contractor, the State may procure the materials or supplies from other sources and hold the Contractor responsible for any excess cost occasioned thereby, provided, that if public necessity requires the use of materials or supplies not conforming to the specifications they may be accepted and payment therefore shall be made at a proper reduction in price.

ATTACHMENT B – PAYMENT PROVISIONS

The maximum dollar amount payable under this contract is not intended as any form of a guaranteed amount. The Contractor will be paid for products actually delivered or performed, as specified in Attachment A, up to the maximum allowable amount specified on page 1 of this contract.

- 1. Prior to commencement of work and release of any payments, Contractor shall submit to the State:
 - a. a certificate of insurance consistent with the requirements set forth in Attachment C, Section 8 (Insurance), and with any additional requirements for insurance as may be set forth elsewhere in this contract; and
- 2. Payment terms are **Net 30** days from the date the State receives an error-free invoice with all necessary and complete supporting documentation.
- 3. All invoices are to be rendered by the Contractor on the vendor's standard billhead and forwarded directly to the institution or agency ordering materials and shall specify the address to which payments will be sent.
- 4. **PRICING:** Contractor shall provide all products F.O.B. delivery to the ordering facility at no additional cost to the State. No request for extra delivery cost will be honored. No charge for packing, shipping, or for any other purpose will be allowed over and above the price quoted.
- 5. Contractor shall submit invoice(s) to facility placing the order.
- 6. Following complete delivery of the items each as specified in Attachment A, and the State's written confirmation to the Contractor of the State's acceptance of those items, Contractor will, within 30 business days, invoice the State in accordance with the rates specified in Attachment A.
- 7. Unless otherwise indicated in a manufacturer's return policy, unopened Products can be returned with no restocking fee up to 30 days from the date of receipt.
- 8. The State Purchasing Card may be used by State Purchasers for the payment of invoices. Use of the Purchasing Card requires all required documentation applicable to the purchase. The Purchasing Card is a payment mechanism, not a procurement approach and, therefore, does not relieve State Purchasers from adhering to all procurement laws, regulations, policies, procedures, and best practices.
