STANDARD CONTRACT

1. **Parties.** This is a contract between the State of Vermont, Department of Buildings & General Services (hereinafter called “State”), and Reinhart Foodservice LLC, with a principal place of business in Richmond, VA, (hereinafter called “Contractor”). Contractor’s form of business organization is Limited Liability Company. It is Contractor’s responsibility to contact the Vermont Department of Taxes to determine if, by law, Contractor is required to have a Vermont Department of Taxes Business Account Number.
2. **Subject Matter.** The subject matter of this contract is commodities generally on the subject of Food Replenishment. Detailed requirements to be provided by Contractor are described in Attachment A.
3. **Maximum Amount.** In consideration of the commodities to be provided by Contractor, the State agrees to pay Contractor, in accordance with the payment provisions specified in Attachment B, a sum not to exceed \$2,000,000.00.
4. **Contract Term.** The period of contractor’s performance shall begin on January 1, 2022 and end on December 31, 2023 with the option to renew up to two additional one-year periods.
5. **Prior Approvals.** This Contract shall not be binding unless and until all requisite prior approvals have been obtained in accordance with current State law, bulletins, and interpretations.
6. **Amendment.** No changes, modifications, or amendments in the terms and conditions of this contract shall be effective unless reduced to writing, numbered and signed by the duly authorized representative of the State and Contractor.
7. **Termination/Cancellation/Rejection.** The State specifically reserves the right upon written notice to immediately terminate the contract or any portion thereof at no additional cost to the State, providing, in the opinion of its Commissioner of Buildings and General Services, the products supplied by Contractor are not satisfactory or are not consistent with the terms of this Contract. The State also specifically reserves the right upon written notice, and at no additional cost to the State, to immediately terminate the contract for convenience and/or to immediately reject or cancel any order for convenience at any time prior to shipping notification.
8. **Attachments.** This contract consists of 19 pages including the following attachments which are incorporated herein:

ATTACHMENT A – STATEMENT OF WORK

The Contractor shall provide:

- 1.1. Deliveries may be made weekly or bi-weekly according to paragraph 3. All deliveries are to be made in three compartment trucks sections into frozen, dry, and refrigerated. All deliveries must be inspected and signed for by a Food Officer at the time of delivery.
- 1.2. All products provided by the contractor must meet all federal, state, and local standards for quality and safety requirements. Products not meeting these standards will be deemed unacceptable and return to the contractor for credit at no charge to the State. All products are First Quality – Grade A, unless otherwise specified.
- 1.3. The State may upon request inspect the contractor’s warehouse and trucks. The inspection will be by the State or representatives of the State as appointed by the Office of Purchasing & Contracting. It will be clean, free of insects and rodents, adequate for shipping and delivery products (dry, chilled, or frozen), meet or exceed any USDA or FDA requirements.
- 1.4. The State may upon request, require the contractor to provide accurate, reliable, and timely reports regarding invoices, statements, credits and utilizations.
- 1.5. Prior to the execution of the contract the contractor will provide the State the names and contact information for a primary and secondary representative who will be responsible for the following: contract administration, receiving and processing orders for all centers, ensure on-time delivery and resolving any supply discrepancies, and be available on a daily basis to the State Food Service Supervisors and Office of Purchasing & Contracting. Contractor will be expected to participate in regularly scheduled food services supervisor’s meetings if required.
- 1.6. Contractor must be willing to delivery to all parties indicated on the attached list of “Facilities & Interested Parties.”
- 1.7. Food price lists contain food products currently in use at the facilities and has been agreed upon by all parties, for use under this contract. Products listed in this list shall remain firm through the contract period. Product additions and deletions require PRIOR approval. Notification of additions and deletions will be forwarded to the contractor by the Office of Purchasing & Contracting. Food Service Supervisors at each facility and interested parties shall receive new price list at least 5 working days prior to the next two - month calendar months’ period. Lists must show effective date of pricing. Once contractor has emailed new list to all interested parties, prices will remain firm and no price changes allowed during the two- calendar month period.
 - 1.7.1. Prices honored by the State will be those in effect the **DATE THE FACILITY PLACES THE ORDER AND NOT AT THE TIME OF DELIVERY OR INVOICE. BACK ORDERS WILL BE PRICED AT POINT OF ORDER. THE PRICE LIST MUST REFLECT CONTRACTOR’S PRODUCT NUMBER IN NUMERICAL ORDER.**
 - 1.7.2. Contractor shall email one copy of the food list and pricing to the Office of Purchasing and Contracting.
- 1.8. Contractor must maintain an average of 98% stock availability. Upon receipt of order, contractor immediately notify ordering site of out of stock/not available products. (Note: Out of stock/no available product situations may be based for cancellation of contract and/or charged back for additional cost obtained such products elsewhere).
 - 1.8.1. Suitable substitution shall be made in the event of out of stock/not available product situation at the same price as the product that is on contract. Such situation shall be same

grade, quality, etc. Substitutions shall not be made on a continued basis. Explanation of repeated/continued substitution shall be made to the State in a timely manner. If contractor cannot supply an acceptable substitution, the Food Service Supervisor must contact the Office of Purchasing and Contracting and request “authorization” to purchase from an alternate source. It will be left to the Food Service Supervisor’s discretion as to whether or not a “partial fill” order will be accepted. Repeated out of stock, substitutions and/or partial fills made by contractor must be reported by the Food Service Supervisor by email to the Office of Purchasing and Contracting. Contractors are to indicate all “out of stock”, “partial fills” and “substitutes” on their invoices.

- 1.9. Contractor shall provide Grade A, First Quality, label brand. Bidders are to furnish a Food label comparison chart with their bid. If contractor must change label brand, a written notification must be forwarded to the Office of Purchasing and Contracting for approval. The State will have the option to accept the changes or buy product elsewhere.
 - 1.9.1. The State reserves the right to request specific samples for food cutting at any time throughout the contract period. The State reserves the right to have a product of questionable nature tested by the Vermont Agency of Agriculture or the Vermont Department of Health.
 - 1.9.2. The bidder’s response reflects primary food items to be purchased from this contract. Fill rate is to be 98% minimum, or each item requested. CONTRACTORS ARE TO INDICATE FOOD PROCESSED OR PACKED IN THE STATE OF VERMONT.
- 1.10. The State will work with the contractor to establish a procedure to ensure prompt payment to fully reconciled invoices. The contractor will not limit or withhold service to a facility due to pass due invoices. Contractor is to include their proposed policy for overdue invoices in their response. As noted in the invoice paragraph disputed and un-reconciled invoices are not to be considered past due.
- 1.11. Any claim of product delivery that is unusable (damaged, rotten, inedible, and unacceptable substitution, etc.) shall be resolved within three (3) days.
- 1.12. Invoicing in accordance with the contract is essential for timely payment to the contractor. Contractor must work with the State to develop procedures that will ensure a minimum or errors. Invoices are to reflect product number of each item as to easily matched to price list for price verification by facilities. Contract and non-contract items shall not be comingled on the same invoice. Contractors are requested to either invoice non-contract items on a separate invoice or at the bottom of the invoice for contract items. Invoices to be rendered by contractor to each individual facility responsible for the order. Contractor shall be responsible for showing the ordering facility, contractor’s product number, date of order, unit and extension prices on all invoices. Substituted items must be reflected on invoices at the contract price. If invoice reflects a higher price for items or substitutes a higher price, the contractor’s invoice will be cut-back to the price at the time of the order, however, if the pricing is lower than time of order this price will prevail in the payment. If more than a quarter of the items on the invoice priced incorrectly, the contractor will be expected to reissue a correct invoice to the facility. It will be contractor’s responsibility to ensure correct pricing. The contractor is advised that invoices with discrepancies will take longer to process, and the State shall not be held responsible.
- 1.13. The state reserves the right to conduct in-depth contract price audits throughout the contract period.
- 1.14. The State upon request has the right to add an additional facility with a 30-day written notice or remove a facility with a 60-day written notice. Bidders are to bid all

locations indicated.

2. **REPORTING REQUIREMENTS:** Contractor will be required to submit quarterly product sales report to the Purchasing Agent pursuant to the schedule below detailing the purchasing of all items under this Contractor. Contractor's reporting shall state "no activity" for any month in which there is no activity during a quarterly reporting period.

2.1. The reports shall be an excel spreadsheet transmitted electronically to the Purchasing Agent.

2.2. Reports are due for each quarter as follows:

- 2.3. Failure to meet these reporting requirements may result in suspension or termination of this Participating Addendum.
- 2.4. Notwithstanding the fact that any payment obligation for sales by contractor to any political subdivision or college, pursuant to "Purchasing Entities," below, shall be solely between the political subdivision or college and the contractor, the contractor must include, in reporting to State, the figures on quantities sold by contractor to, and amounts paid to contractor by, any such political subdivisions or independent colleges.
3. **DELIVERY:** Responsibility for product delivery remains with Contractor until the product is properly delivered and signed for. Contractor shall securely and properly pack all shipments in accordance with accepted commercial practices. Upon delivery, all packaging and containers shall become the property of the State, unless otherwise stated. Delivered goods that do not conform to the specifications or are not in good condition upon receipt shall be replaced promptly by the Contractor.
4. **QUALITY:** All products will be new and unused. All products provided by the Contractor must meet all federal, state, and local standards for quality and safety requirements. Products not meeting the requirements of this section will be deemed unacceptable and returned to the Contractor for credit at no charge to the State.
5. **DEFAULT:** In case of default of the Contractor, the State may procure the materials or supplies from other sources and hold the Contractor responsible for any excess cost occasioned thereby, provided, that if public necessity requires the use of materials or supplies not conforming to the specifications they may be accepted and payment therefore shall be made at a proper reduction in price.

7. **Purchasing Entities:** This Participating Addendum may be used by (a) all departments, offices, institutions, and other agencies of the State of Vermont and counties (each a "State Purchaser") according to the process for ordering and other restrictions applicable to State Purchasers set forth herein; and (b) political subdivisions of the State of Vermont and any institution of higher education chartered in Vermont and accredited or holding a certificate of approval from the State Board of Education as authorized under 29 V.S.A. § 902 (each an "Additional Purchaser"). Issues concerning interpretation and eligibility for participation are solely within the authority of the State of Vermont Chief Procurement Officer. The State of Vermont and its officers and employees shall have no responsibility or liability for Additional Purchasers. Each Additional Purchaser is to make its own determination whether this Participating Addendum and the Master Agreement are consistent with its procurement policies and regulations.

ATTACHMENT B – PAYMENT PROVISIONS

The maximum dollar amount payable under this contract is not intended as any form of a guaranteed amount. The Contractor will be paid for products actually delivered or performed, as specified in Attachment A, up to the maximum allowable amount specified on page 1 of this contract.

1. Prior to commencement of work and release of any payments, Contractor shall submit to the State:
 - a. a certificate of insurance consistent with the requirements set forth in Attachment C, Section 8 (Insurance), and with any additional requirements for insurance as may be set forth elsewhere in this contract; and
2. Payment terms are **Net 30** days from the date the State receives an error-free invoice with all necessary and complete supporting documentation.
3. All invoices are to be rendered by the Contractor on the vendor's standard billhead and forwarded directly to the institution or agency ordering materials and shall specify the address to which payments will be sent.
4. **PRICING:** Contractor shall provide all products F.O.B. delivery to the ordering facility at no additional cost to the State. No request for extra delivery cost will be honored. No charge for packing, shipping, or for any other purpose will be allowed over and above the price quoted.
 - a. Prices on this contract must be firm until February 28, 2022. After February 28, 2022, the contractor will be allowed to make price changes every two calendar months using the same formula (Formula: the cost will be the contractor's delivered invoice cost to the contractor's facility when the two-month pricing is issued plus fixed case fee of \$4.25) that are listed. New pricing for the first two calendar months will be due on February 22, 2022 and are due to the Office of Purchasing & Contracting electronically 5 working days before the next (two calendar months) pricing goes into effect thereafter.
 - b. All prices to the user of this contract will be net F.O.B. Delivered.
 - c. A single fixed case fee applies to each case. The fixed case fee will remain firm for the duration of the contract. Split pricing is calculated by dividing the full case by the number of units and adding it the applicable markup to the unit. (i.e., spices).
 - d. Pricing for contracted and non-contracted items. Split pricing is calculated by dividing the full case by the number of units and adding the applicable markup to the unit.
 - e. Contractor does not have a backorder policy. All out of stock items at the time of order placement/delivery need to be reordered by the facility.
5. Contractor are expected to forward on to the State Facilities any allowances, specials, or promotions.
6. Contractor shall submit invoice(s) to the facility placing the order.

7. Following complete delivery of the items, each as specified in Attachment A, and the State's written confirmation to the Contractor of the State's acceptance of those items, Contractor will, within 30 business days, invoice the State in accordance with the rates specified in Attachment A.

PRODUCT RETURN AND CREDIT POLICY

Last Update: September 1, 2021

This policy sets forth the procedures for returning products purchased from Performance Foodservice and its subsidiaries (collectively, "Reinhart and/or Performance Foodservice). We appreciate your adherence to these policies, as they are designed to ensure product quality and food safety, reduce the processing time for customer credits and minimize product loss.

Delivery

At delivery, your Reinhart driver will make **every effort to assure** that your order is complete. **However**, please **be sure to** take the time necessary to review your order for accuracy when the driver is present. Any item may be returned to Reinhart for full credit at time of delivery for items that have not left Reinhart's possession; provided, however, that special order items require special authorization before any return can be accepted. Our ability to accept returns after delivery is limited for safety reasons.

If a product is short or damaged upon delivery, your Reinhart driver can adjust the delivery invoice in order to give you immediate credit for the item. Credits for partial cases will be issued as appropriate.

Timing

All delivery issues (non-conforming products, shortage, loss or damage) must be called into Reinhart Customer Service **within 24 hours of delivery**.

Information Required for Returns

To process a return after delivery, please telephone Reinhart Customer Service. The following information must be provided in order to ensure that credits are processed in a timely manner:

- Reinhart customer account number;
- Invoice number;
- Date of delivery;
- Item number and quantity to be returned;
- Picture of the item to be returned;
- Picture of all box labeling and the box with brand name; and
- Reason for return

Conditions for Return

Reinhart FoodService as a HACCP certified facility follows all HACCP guidelines.

The following additional limitations on product returns apply for safety reasons:

- The following products **may not be returned after delivery**: fresh fish and seafood, refrigerated raw poultry, refrigerated egg products, refrigerated raw ground beef and refrigerated ready-to-eat products identified as potentially hazardous and requiring a control point (e.g., refrigerated imitation crab, deli meat and prepared wet salads).
- All returned merchandise must be in the original packaging, uncompromised, intact and resalable.
- Acceptable shelf life (as determined by Reinhart's standard operating procedures) must remain on all returned products.
- All refrigerated and frozen products being returned must be stored at the proper temperature.
- Products without HACCP limitations (e.g., dry groceries) must be returned within 14 business days and with adequate shelf life remaining.
- **No credit will be issued until our Quality HACCP inspector has confirmed the returned product is in re-saleable condition.**

Method of Return

All refrigerated and frozen products must be returned in a Reinhart temperature-controlled vehicle. Please contact your Reinhart Sales Consultant to make pick-up arrangements.

Special Order Items

Special Order claim adjustments for damage credit are allowed only at the time of delivery. Pick-ups for vendor or manufacturer return need special authorization.
